CLASS ACTION

Plaintiffs Yvonne Becker, Christopher Nobles, Rosa Ramirez, Valerie Seyler, Jannien Weiner (collectively "Plaintiffs"), and the Class, by their counsel, respectfully move the Court for entry of an order approving (1) attorneys' fees to Class Counsel in the amount of \$10,833,333 (one-third (1/3) of the \$32,500,000 Settlement Fund), (2) reimbursement of \$180,668 in litigation expenses, (3) \$416,000 in Settlement Administration Expenses, (4) Case Contribution Awards in the amount of \$15,000 to each of the Named Plaintiffs as Settlement Class representatives, and (5) for other such relief as the Court may deem just and proper.

The grounds for the requested relief are set forth in the accompanying Plaintiffs' Memorandum of Law in Support of Plaintiffs' Motion for Attorneys' Fees, Expense Reimbursement, Settlement Administration Expenses, and Case Contribution Awards, the Declaration of Michelle C. Yau in Support of Plaintiffs' Motions and attached Exhibits,

the Declarations of Yvonne Becker, Rosa Ramirez, Christopher Nobles, Valerie Seyler, Jannien Weiner, and Jeffrey Mitchell from Analytics Consulting, LLC all filed in support of this Motion, as well as argument of counsel and the record on file.
